### **Objectives:**

The Members of the Board of Centum Electronics Limited (Centum) are provided with necessary updates to familiarise themselves with the Company, its management and operations from time to time. The familiarisation programme aims to update the Directors on a continuous basis on significant developments in and around the Company and in the business model where the Company operates so as to enable them to take well informed decisions in a timely manner.

The familiarisation programme also aims at providing updates to Independent directors to discharge their roles, responsibilities rights and duties under the Companies Act 2013 and SEBI Listing Regulations.

### **Induction and Familiarisation Programme for the Directors:**

Some of the practices in the familiarisation programme are conducted on a continuous basis and some on case to case basis. Further, there are specific practices which the Company follows at the time of induction of a new director. The familiarisation programme at Centum broadly covers the following:

1. The Independent Directors are made aware of their roles, duties and responsibilities at the time of their appointment through a formal letter of appointment which stipulates the terms and conditions of their engagement.
2. The Company shall through its Executive Directors/Senior Management Personnel conduct programs/ presentations periodically to familiarize the Independent directors with the strategy, operations and functions of the company.
3. The Company circulates news and articles related to the industry on a regular basis and will provide specific regulatory updates from time to time.
4. The Company will conduct/ circulate an introductory familiarization program/presentation, when a new Independent Director comes on the Board of the Company.
